

Please see the following questions and responses regarding RFP #2015-001 Custodial Services for the Orange County Schools.

#	Vendor Question	District Response
1	Please provide the current contracted annual spend for custodial services with Facilico.	The total expenditure for 2014-2015 was \$650,221.06.
2	Please verify School Administrative Offices are not included in this custodial service request.	See the exclusions and specifications in the RFP. Administrative offices will be excluded.
3	It is my understanding that under the current custodial service contract Gymnasiums and Media Centers (Libraries) are not part of the current vendors cleaning contract and may be deducted from the current request for services if the cost is prohibitive, please verify.	Vendors should price according to specifications of the RFP.
4	Please provide the number of student days and teacher days per school. (i.e. 180 student days, 187 teacher days, etc...)	The school calendars are approved annually. For the 2015-2016 school year, traditional teachers report on August 18th with their last day of June 13, 2016. Students report on August 24, 2015 through June 9, 2016 Hillsborough Elementary is year round and the teachers report July 6, 2015 through June 7, 2016. Students on the year-round schedule report July 13, 2015-June 3, 2016. The calendar is based upon 183 student days.
5	Please provide Student and Faculty/Staff population per school.	Student capacity and counts are included in Attachment 1 of the posted RFP. Faculty counts are as follows: Central Elementary (46), Efland Cheeks Elementary (49), Hillsborough Elementary (57), Pathways Elementary (62), AL Stanback Middle (77), CW Stanford Middle (61), Gravelly Hill Middle (47), Cedar Ridge High (91), Orange High (101)
6	Per the OCS Cleaning Specifications on page 3, the Specifications for "Corridors" seems to be specs for restroom cleaning. Do you have additional specs for Corridors? Please clarify.	We do not have additional specifications for corridors and will utilize the applicable items in the specifications listed in the RFP under Corridors.
7	We were told that the school sessions for Hillsborough Elementary school differs from the others in that it is "in session" year round although it closes for 2 or 3 weeks at varying times throughout the year. Can you please clarify this?	Hillsborough Elementary is year round and the teachers report July 6, 2015 through June 7, 2016. Students on the year-round schedule report July 13, 2015-June 3, 2016. The calendar is based upon 183 student days
8	I heard on the site tours that administrative office areas are not part of the work scope and therefore not the responsibility of the contractor but I do not see anything in the RFP that states this. Can you please clarify?	See the exclusions and specifications in the RFP. Administrative offices will be excluded.
9	Can you please clarify the restroom requirement by identifying either the number of fixtures to be cleaned or the square footage of the restrooms per school? We were not able to get a handle on this during the site tours. It would be impossible to ascertain this information in the time allotted for the tours.	Vendors should gather information needed for their bids via on-site inspections. No additional information will be provided. Vendors may note an exception to their bid if they are unable to derive information needed for pricing.
