Orange County Public School System APPEAL FOR ATHLETIC PARTICIPATION FOR TRANSFERRED STUDENTS

Board Policy 4125: A student who is granted a voluntary transfer away from the base or assigned school shall not participate in athletic activities that come under the jurisdiction of the North Carolina High School Athletic Association (NCHSAA) and the State Board of Education for 365 days from the first approved transfer date. The Superintendent or his/her designee may review appeals of this section of Policy 4125 and may grant permission for students to participate in athletic activities based upon such hearings. The Superintendent shall require written regulation and procedures to govern appeals of this section of Policy 4125. Students entering ninth grade for the first time are eligible to participate in athletic activities and are not required to file an appeal. 4125 R & P To appeal policy 4125, the Orange County Public School System Appeal for Athletic Participation must be completed and submitted to the District Athletic Director as the Superintendent's designee.
