K12PaymentCenter - same online system that parents use to pay for their child's breakfast/lunch.

Parents can set up monthly payments in bill pay via their bank according to the billing schedule provided. This will be a real check mailed to OCS. Parents please reference your child/children's name/school name in the memo section for proper posting.

Payments are not to be made weekly. Payments must be made monthly on the due date.

Other Information:

Bills / Late Charges / Withdrawals - Bills are emailed as a courtesy. This billing schedule is your bill. Please follow monthly. Do not wait for an invoice via email. Late charges will be assessed according to the date listed above at \$10 PER CHILD. Child/children will be withdrawn the day after late fees are posted.

Withdrawal from Program - A two weeks notice is required for withdrawals. The withdrawal form must be submitted to the School Community Relations Office via email/in person/ drop box

Billing- Weeks are billed at the full rate. The only weeks that are prorated are weeks that include a Teacher Workday, Thanksgiving, Christmas Break, and the last week of school. In the case of inclement weather, our office will adjust accounts accordingly, if 3 or more days are missed in a week.

There will be no 2 party billing. Only 1 account per child is permitted. Parents are responsible for submitting their portion of the amount due.

Late Pick up fees - are due by the close of the week in which the late fee occurred. Unpaid late pick up fees will result in the child/children being withdrawn from the program.

Tax Statements for 2022 will be emailed out by January 31, 2023. If you would like to pay additional money for your 2022 tax statement, you will need to make all payments by Friday, December 16, 2022 by 11 a.m.
